**Agenda Item:** (Review Commercial Residential District)

A change to the text pertaining to the Town of Durand Zoning Ordinance in Section 13-1-33-4 (Commercial Residential District Conditional Uses) should be as follows: 4c, 4g, 4h, 4i, 4j, 4k, and 4l should be eliminated.

The following changes to Exhibit A should be implemented:

Green Houses – Changed to Permitted Use

Antique Shop, Art Gallery – Total Line Deleted

Child Day Care Home – Conditional Use

Farm and Home Business – Total Line Deleted  
General Retail & Services – Permitted Use

Home Business – Permitted Use

Home Occupation – Permitted Use

Lodging/ Hotel – Conditional Use

Mini-Storage – Permitted Use

Business Offices – Permitted Use

Roadside Stand – Permitted Use

Manufactured Home Park – Conditional Use

Temporary Concrete or Asphalt Plant – Conditional Use

A question arose regarding the use of properties within the Town of Durand for holding Weddings, Reunions, and/or Business Meetings. This is not addressed in the zoning ordinance at the present time, but the committee members felt these types of activities should be categorized as Commercial Entertainment Facilities.

**Agenda Item: (Continue Discussion on Quality of Ground Water)**

Chairman John Wayne stated he had no additional information regarding the Quality of Ground Water issue. Stan Ridgeway gave an update regarding the Town of Durand efforts regarding the ground water issue. He stated the Durand Town Board is working on a resolution regarding ground water nitrate levels in the Town of Durand.
