Rural Mutual Insurance representative Steve Berger gave a summary of coverage and premiums for the Town of Durand.

Resolution to Levy Special Assessment (Hwy 10 Assessor's Plat)

Cedar Corp has been in tough with Stan, and let him know that a special assessment cannot be split equally by the nine property owners. Property owners must pay their own assessment according to land values. Some of these amounts have increased, some have decreased. In order to pass the resolution, a public hearing must be held. The public hearing will be held within the next couple months.
