Treasurer's Report

Payment of Vouchers

Chairman's Report

Stan gave the board the following updates:

Stan met with Gary Fahnel of Country Coaches, regarding the number of junked vehicles and busses on his property. Gary said that the vehicles are all for sale, but he will work on putting them in the back of the property.

Bob Kees has started constructing a building on his property without the proper permit. Galen Seipel has mailed a letter to him stating that a permit must be applied for by March 24.

The City of Durand had hired a consultant to create a Fire District, consolidating the rural and city fire departments.

Public Comments

Mark Weiss said that he was approached with an inquiry regarding ATV trails in the Town of Durand. So far, no residents have brought up this topic to discuss.

Town Roads

The board reviewed pavement ratings with Pepin County Highway Commissioner John Hanz. They will choose roads with ratings of 4,5, and 6 for 2017 projects. Also discussed was the importance of spending budgeted highway money on the scheduled projects, or GTA money could be lost. The projects for 2016 were either not started at all, or left incomplete. John will also see what can be done to remedy the ongoing issue of water settling on both sides of the Dorwin's Mill Bridge.
