**Approval of October 20, 2020 Board Meeting Minutes**

Motion made by Penny Bauer and seconded by Mark Weiss for Clerk Lisa Ridgeway to pay vouchers. All in favor-3, opposed-0, motion carried.

**Public Comment**

**Brunner Rd Grant Project**

There were some issues at the State level, which have delayed the start date as to when the money will be available, so Russ at Cedar Corp feels this project should be held off until 2021. The money must be spent within 3-5 years, so this delay will not be an issue.

**Routes to Recovery Grant Approval**

Stan Ridgeway has submitted all of the purchases for the Routes to Recovery Grant, and included the transfer of remaining funds to the Durand Ambulance.
