**Approval of November 12, 2019 Regular Board Meeting Minutes**

**Treasurer's Report**

The Treasurer's report was presented to the Board by Treasurer Audrey Bauer. Balance on hand as of November 29, 2019, was \$215,497.83.

**Payment of Vouchers**

Vouchers presented to the Board for payment by Clerk Lisa Ridgeway, totaled \$20,782.04. Motion made by Stan Ridgeway and seconded by Mark Weiss for Clerk Lisa Ridgeway to pay vouchers. All in favor-3, opposed-0, motion carried.

**Chairman's Report**

Both grants have been submitted- the LRIP for Pleasant Ridge, and Cedar Corp grant for Brunner, Kee's and Dorwin's Mill Rd.

The Town Hall will be emptied out Saturday, January 11, at noon. After this, the title paperwork can be signed, and the sale will be finalized.
