Cemetery Ordinance

Penny Bauer made a motion to approve the adopted 2022-2 Town of Durand cemetery ordinance and Mark Weiss seconded the motion. All in favor-3, opposed-0, motion carried.

Approval of Durand Rural Fire Department Inc. 2023 Budget Mill Rate Increase

Mill rate increase from .00027 to .00031 which is about \$4 per \$100,000 assessed value. With this increase, the generated rate for the fire department will be about a \$1,200 increase. Stan Ridgeway made a motion to approve the mill rate change from .00027 to .00031 and Penny Bauer seconded the motion. All in favor-3, opposed 0, motion carried.
