## **Chairman's Report**

Chairman Stan Ridgeway updated the board regarding the Dorwin's Mill Rd project. Stan received a call from Doug Gruber with the Highway Department letting him know that the measurements were incorrect, so they will not complete the wedging portion in order to stay under the quoted amount. The project is set to begin June 13.

Stan has received a quote for the differences between a \$500 and \$1,000 deductible from Steve Berger at Rural Mutual Insurance. The differences in premium would be \$3.00 and \$7.00 respectively.
