TRIP paperwork has been received from the Department of Transportation, and the Pepin County Highway Department will begin to take bids for the repair of Rustad Lane. John Hanz, Highway Department Commissioner will attend the next town meeting to open and accept bids.

Public Comments

Mark Weiss attended the Wisconsin Towns Association meeting in Wausau this month. He reported that Rick Stadelman has retired, and that there is a WTA joint meeting to be held in Peirce County on October 16 at the Town of Union town hall. Mark also reported that WTA has new sets of training videos available for purchase for Board Members and for Clerks and Treasurers. Clerk Lisa Ridgeway will place an order for them.
