**Approval of January 10<sup>th</sup>, 2023 Board Meeting Minutes**

**Treasurer's Report**

**Payment of Vouchers**

Vouchers presented to the Board for payment by Clerk Brittany Myers, totaled \$306,245.20. Motion made by Penny Bauer and seconded by Mark Weiss for Clerk Brittany Myers to pay vouchers. All in favor-2, opposed-0, motion carried.

**Chairman's Report**

Chairman Stan Ridgeway has been working with Chris Bates about the road projects and with all the increase of cost for everything, we won't be able to stay within budget for the Brunner Road Project, and talking about maybe just work with the county on a new culvert and fixing the road up. Chris is looking into this more and they will touch base and keep Cedar Corp in the loop as well.

**Public Comment**

Vicki Wayne stated Ron Jasperson was at their house last week and Ron Jasperson will be in contact with Stan Ridgeway to put the Wayne property on next month's agenda. Dan Bauer suggested using the ARPA money if there were any roads signs or stop signs needing replaced.

**Steve Berger/Rural Mutual**

Rural Mutual Insurance representative Steve Berger gave a summary of coverage and premiums for the Town of Durand.

**Storage Unit**

Stan Ridgeway made a motion to rent a storage unit from Greg Prissel, Mini storage for the Town of Durand, for \$600 a year and Mark Weiss seconded. All in favor – 3, opposed – 0, motion carried.

**Flashing Beacon on Hwy 10**

Mark Weiss made a motion and Penny Bauer seconded to purchase the flashing beacon light for Hwy 10. The total cost of the unit is \$2,195 plus having the county install it. Once this is installed, we can cancel the Xcel Street light.
